ARLINGTON, TX - Thousands of Croatian people remain displaced by the devastating war in Bosnia and Herzegovina. The victims of this war are for most part women, children, the elderly and the physically and mentally handicapped. They have been removed from all that is familiar and have nothing.

St. David's Foundation's mission is to provide tangible humanitarian aid to people of Bosnia and Herzegovina and to assist in reconstruction. St. David's works in concert with the Franciscan Friars of Bosnia-Herzegovina, recognized Non Governmental Organizations (NGOs) from other nations, as well as assisting local relief agencies. St. David's is multidenominational and is nonpartisan in its relief. The aid is distributed in areas of need without regard to race, ethnicity, national or religious persuasion. St. David's Relief Foundation provides evidence to the people of Bosnia-Herzegovina that they have neither been forgotten, nor forsaken.
